The reasons for my objections are as follows -

1/ Whalley Abbey is a holy, religious place and should be kept as such.

2/ There are already four pubs, one nightclub and three other venues that serve alcohol on King Street which is just around the corner from Whalley Abbey.

3/ The local residents particularly those on Church Lane and The Sands will have to tolerate noise nuisance, possibly bad behaviour and extra parking which is currently a serious problem in that area.

4/ Requesting a licence to sell alcohol should not be something the Artisan (being a charity) should be doing in a religious place.
