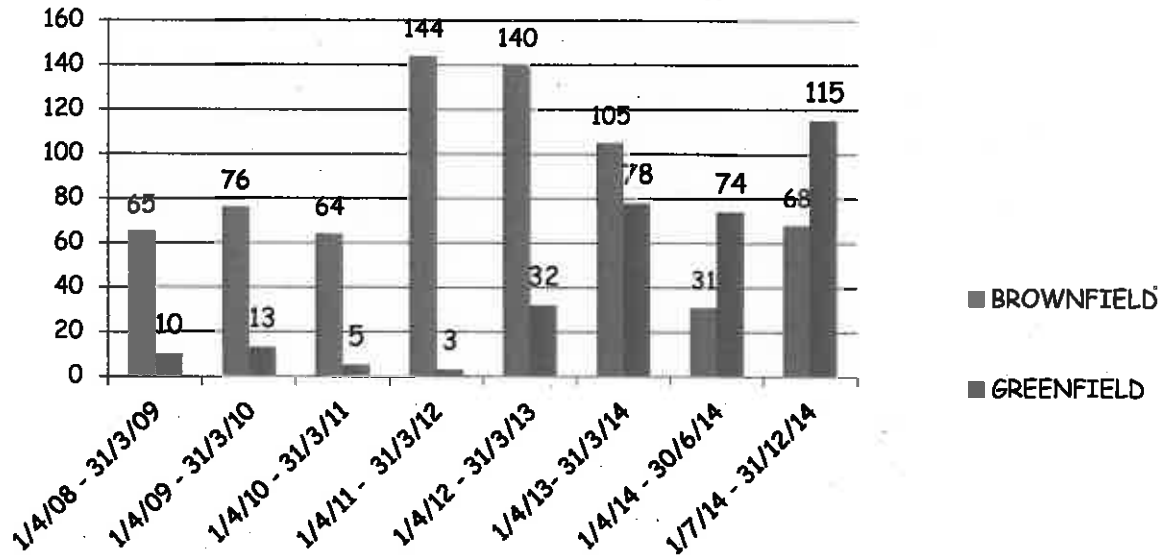

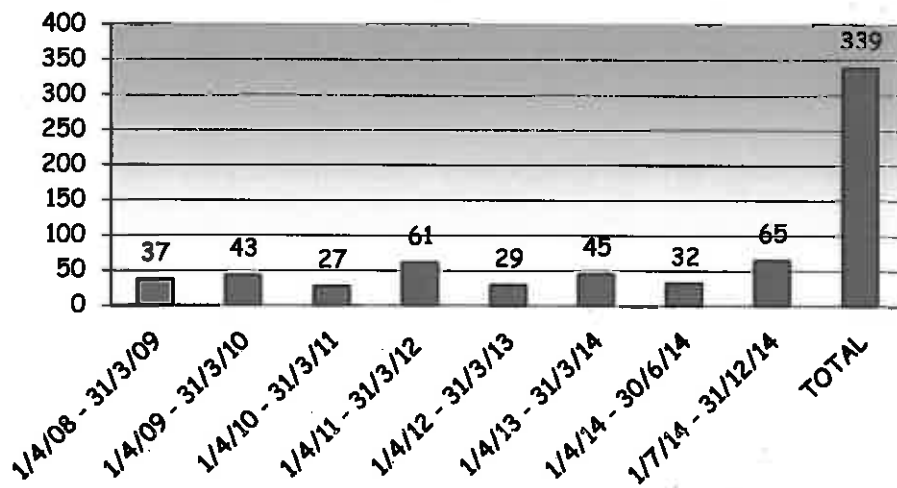

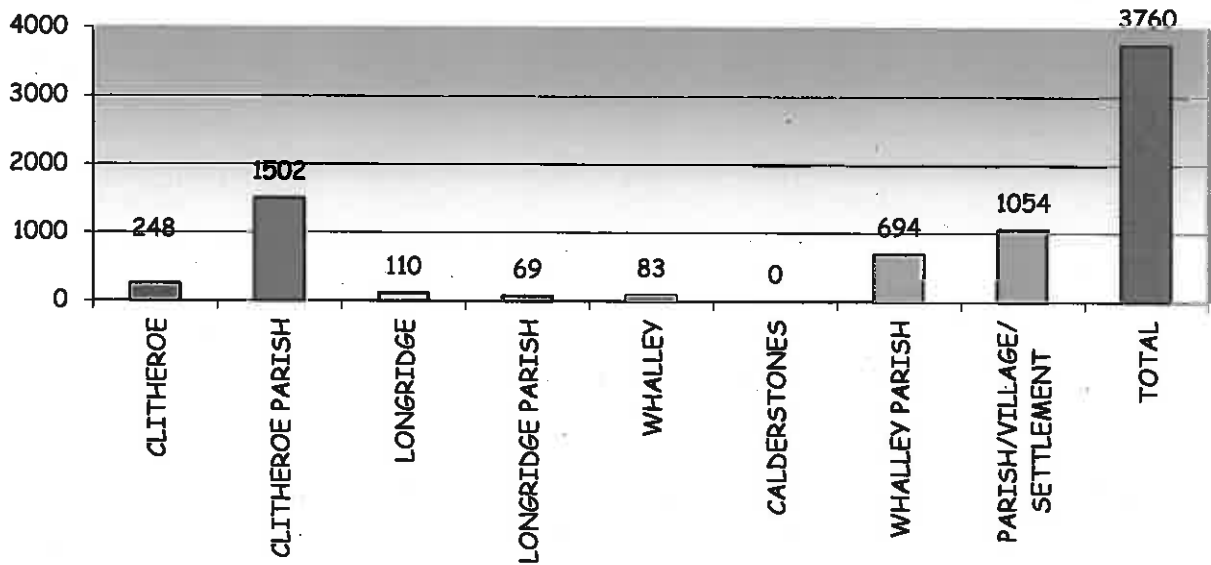

4. In the current housing land there are 3760 dwellings currently with planning permission and they are situated within Clitheroe, Longridge, Whalley and other parishes.

5. The Core Strategy was formally adopted at a meeting of the Full Council on 16 December 2014. Land for residential development will be made available to deliver 5,600 dwellings, estimated at an average annual completion target of at least 280 dwellings per year over the period 2008 to 2028. In terms of the calculation of housing supply, the Council adopt the Sedgefield approach.
6. Since 2008 a total of 1023 dwellings have been completed.

For housing supply and Core Strategy Monitoring purposes the figures for Whalley and Calderstones are combined to assess housing supply in Whalley as defined in the Core Strategy Housing Distribution Model. It is recognised that the approach introduces an element of double counting against the other settlements modelled requirement (some 35 dwellings) but this is not considered significant as it represents such a small amount of dwellings compared to the requirement and is also taken as an average level of development as the anticipated minimum across the Borough.

## Housing Land Position at 31<sup>st</sup> December 2014

### Annualised requirement

The Core Strategy was adopted on 16<sup>th</sup> December 2014. Policy H1 sets an overall requirement of 5600 dwellings for the plan period 2008 - 2028 which equates to 280 dwellings per year. The 5 year requirement is calculated as follows:

### Deductions from the supply

Sites with planning permission are usually considered deliverable until the permission expires unless there is clear evidence that the sites will not be delivered within the five years as per footnote 11 to paragraph 47 of NPPF. The following sites have planning permission but are not considered deliverable and are excluded from the 5 year supply:

\* site at Victoria Mill has pp for 70 dwellings and is included in the overall figures. However the council has resolved to approve a further scheme for 40 dwellings which is subject to a section 106 agreement which is likely to be implemented in favour of the scheme for 70. Therefore 30 deducted.

A further site East of Clitheroe Road Whalley has an extant outline planning permission for 206 dwellings. It has been indicated that the number of dwellings in the reserved matters application is likely to be about 155. This amounts to a reduction of 51 dwellings. Since the 10% slippage allowance would equate to a deduction of about 20 dwellings, a further 31 dwellings are deducted from the calculation to fully reflect this. Future surveys will pick up any variations.

#### 2. Specific Large sites

The Council considers that the following sites are deliverable but due to the scale, will not be fully developed in the five year period.

The Strategic site at Standen is identified in the Core Strategy and has outline planning permission for mixed development which includes 1040 dwellings of which 312 are affordable. For the purposes of the five year supply, based on information put forward at the Core Strategy examination, the site is estimated to contribute about 100 dwellings per year for the latter three years of the five year period.

The site south and west of Barrow was granted outline permission on appeal in February 2014 for 504 dwellings of which 151 are affordable. At that appeal, information presented by the appellant supported the delivery of the site in five years at a rate of 100 dwellings per year using 4 builders. For the purposes of the five year supply, the site is estimated to contribute about 100 dwellings per year for the latter three years of the five year period.

The Core Strategy Inspector considered these figures to be broadly reasonable.

A third site at land off Waddington Road, Clitheroe is the subject of a council resolution to grant planning permission once a Section 106 is completed. The site could accommodate up to 275 dwellings. For the purposes of five year supply, it is assumed that the site could deliver 50 dwellings a year for the latter three years of the plan period.

Future monitoring will identify whether any changes need to be made in the light of the progression of the sites and development activity.

Regular monitoring of all permissions and developments will continue to take place and any adjustment made as appropriate.

#### **Windfall allowance**

A windfall allowance is included, based on past development rates and in accordance with definitions in NPPF para. 48 and its glossary.

Past trends have only been considered in relation to the Principal Settlements of Clitheroe; Longridge and Whalley where the Core Strategy seeks to direct the majority of housing development; and the Tier 1 settlements of Barrow, Billington, Chatburn, Gisburn, Langho, Mellor, Mellor Brook, Read and Simonstone (taken and as single settlement) and Wilpshire where a limited amount of development might be allowed in accordance with the Core Strategy. Past trends were not considered in the remaining 23 Tier 2 settlements and locations outside any settlement as the Core Strategy does not anticipate that a significant number of dwellings will come forward in these locations unless certain criteria are met. . .

To ensure a realistic assessment in accordance with the NPPF guidance/criteria past developments were only considered for new build or conversions to new dwellings granted permission since 2008 (base date of the Core Strategy) where:

- The dwellings were constructed or under construction at 31<sup>st</sup> March 2014 (i.e. the permission had been implemented. Lapsed permissions and permissions not started are excluded);
- The sites were within the settlement boundaries (as defined on the former District wide local plan);
- The site was a brownfield site; and
- The site is not a residential garden.

Thresholds were also applied to ensure large sites did not skew trends as follows:

Clitheroe, Whalley and Longridge: 10 dwellings  
 Tier One settlements: 5 dwellings

A total of 137 dwellings were built or under construction in a six year period. This amounts to about 23 dwellings per year. A five year equivalent would be 115.

The allowance will be monitored in successive surveys to show if it needs to be modified. The inclusion of a windfall allowance does not imply that any development will be forthcoming for a particular development.
