2. Applications to register to vote must reach the Electoral Registration Officer at Council Offices, Church Walk, Clitheroe BB7 2RA by midnight on **Tuesday, 29 January 2019**.
3. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Council Offices, Church Walk, Clitheroe BB7 2RA by **5pm on Wednesday, 30 January 2019**.
4. Applications to vote by proxy at this referendum must reach the Electoral Registration Officer at Council Offices, Church Walk, Clitheroe BB7 2RA by **5pm on Wednesday, 6 February 2019**.
5. Applications to vote by emergency proxy at this referendum on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Council Offices, Church Walk, Clitheroe BB7 2RA by **5pm on Thursday, 14 February 2019**. The physical incapacity must have occurred after **5pm on Wednesday, 6 February 2019**. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after **5pm on Wednesday, 6 February 2019**.
