



PUBLIC PATH DIVERSION ORDER

HIGHWAYS ACT 1980

RIBBLE VALLEY BOROUGH COUNCIL

DIVERSION OF PUBLIC FOOTPATH No.12 RIBCHESTER (PART)

This order is made by Ribble Valley Borough Council (the Authority) under Section 119 of the Highways Act 1980 (the 1980 Act) because it appears to the Authority that in the interests of the owner of the land crossed by the footpaths described in paragraph 1 of this Order it is expedient that the line of the way should be diverted.

The applicant has agreed to defray any expenses, which are incurred in bringing the new site of the footpath into a fit condition for use by the public. All limitations will be provided or modified so that they comply with BS 5907:2006

BY THIS ORDER:

1. The public rights of way over the land situated at Glen Avenue, Knowle Green shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up as from the date the Authority certifies that all work to bring the footpath, as described in Part 2 of the Schedule into a fit condition for use by the public has been carried out.
2. There shall at the end of 14 days from the date of confirmation of this Order be a public footpath over the land situated at Glen Avenue, Knowle Green described in Part 2 of the Schedule and shown by a bold broken line on the map attached to this Order.
3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.



SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

Footpath No. 12.

From Ordnance Survey Grid Reference SD 6352 3781, Point A on the Order Plan in a generally north north westerly direction for approximately 23 metres, to Ordnance Survey Grid Reference SD 6351 3783 Point B on the Order Plan, then in a generally north north easterly direction for approximately 23 metres, to Ordnance Survey Grid Reference SD 6352 3785 Point C on the Order Plan and then in a generally north easterly direction for approximately 32 metres, to Ordnance Survey Grid Reference SD 6354 3787 Point D on the Order Plan a total distance of 78 metres. The existing path is shown by a bold line on the Order Plan and marked A – B – C – D.

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

Footpath No. 12.

The new length of path to be created being 2 metres wide from Ordnance Survey Grid Reference SD 6352 3781, Point A on the Order Plan in a generally northerly direction for approximately 21 metres to Ordnance Survey Grid Reference SD 6352 3783, Point E on the Order Plan, then in generally north easterly direction for approximately 15 metres to Ordnance Survey Grid Reference SD 6353 3784 Point F on the Order Plan and then in a generally north north easterly direction for approximately 38 metres to Ordnance Survey Grid Reference SD 6354 3787 Point D on the Order Plan, a total distance of approximately 74 metres. The new path is shown by a bold dashed line on the Order Plan and marked A – E – F – D.

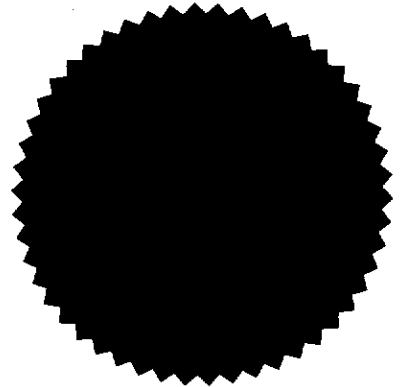

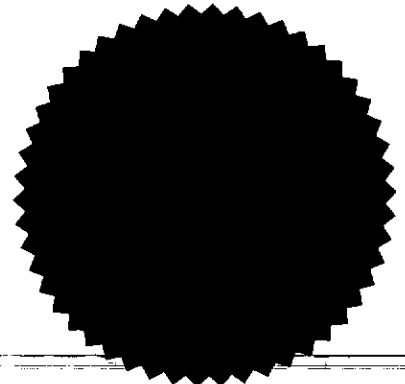
