



PUBLIC PATH DIVERSION ORDER

HIGHWAYS ACT 1980

RIBBLE VALLEY BOROUGH COUNCIL

DIVERSION OF PUBLIC FOOTPATH No. 3 SAWLEY (PART)

This order is made by Ribble Valley Borough Council (the Authority) under Section 119 of the Highways Act 1980 (the 1980 Act) because it appears to the Authority that in the interests of the owners of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the way should be diverted.

The applicant has agreed to defray any expenses, which are incurred in bringing the new site of the footpath into a fit condition for use by the public. All limitations will be provided or modified so that they comply with BS 5907:2006

BY THIS ORDER:

1. The public rights of way over the land situated at Green End, Sawley shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up as from the date the Authority certifies that all work to bring the footpath, as described in Part 2 of the Schedule into a fit condition for use by the public has been carried out.
2. There shall at the end of 14 days from the date of confirmation of this Order be a public footpath over the land situated at Green End, Sawley described in Part 2 of the Schedule and shown by a bold broken line on the map attached to this Order.
3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.



SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

Footpath No. 3.

From Ordnance Survey Grid Reference SD 7727 4700, Point A on the Order Plan in a generally south south easterly direction for approximately 108 metres to Ordnance Survey Grid Reference SD 7732 4691, Point B on the Order Plan and then in a generally southerly direction for approximately 180 metres to Ordnance Survey Grid Reference SD 7729 4673, Point C on the Order Plan and then in a generally south westerly direction for approximately 39 metres to Ordnance Survey Grid Reference SD 7726 4670, Point D on the Order Plan, a total distance of 327 metres. The existing path is shown by a bold line on the Order Plan and marked A – B – C – D.

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

Footpath No. 3.

The new length of path to be created being two metres wide from Ordnance Survey Grid Reference SD 7727 4700, Point A on the Order Plan in a generally south south easterly direction for approximately 139 metres to Ordnance Survey Grid Reference SD 7729 4687, Point E on the Order Plan, and then in a generally south south westerly direction for approximately 68 metres to Ordnance Survey Grid Reference SD 7728 4680, Point F on the Order Plan, and then in a generally south westerly direction for approximately 71 metres to Ordnance Survey Grid Reference SD 7724 4674, Point G on the Order Plan, and then in a generally southerly direction for approximately 18 metres to Ordnance Survey Grid Reference SD 7724 4672, Point H on the Order Plan a total distance of 296 metres. The new path is shown by a bold dashed line on the Order Plan and marked A – E – F – G – H.

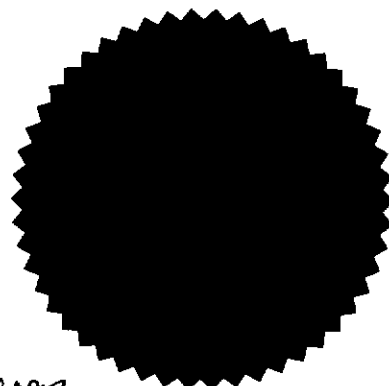

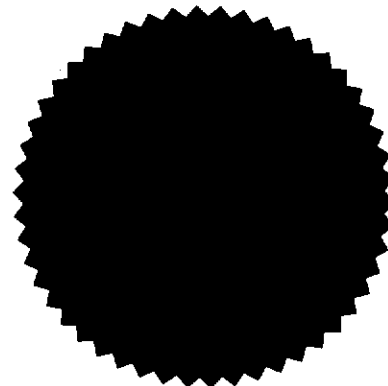
