- Nomination papers must be delivered to the Returning Officer, Council Offices, Church Walk, Clitheroe, BB7 2RA on any day after the date of this notice but no later than 4 pm on Tuesday, 4th April 2023.
- If any election is contested the poll will take place on Thursday, 4th May 2023.
- Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Monday 17 April 2023. Applications can be made online: <https://www.gov.uk/register-to-vote>.
- Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Council Offices, Church Walk, Clitheroe, BB7 2RA by 5 pm on Tuesday, 18th April 2023.
- New applications to vote by proxy at this election must reach the Electoral Registration Officer at Council Offices, Church Walk, Clitheroe, BB7 2RA by 5 pm on Tuesday, 25th April 2023.
- Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Council Offices, Church Walk, Clitheroe, BB7 2RA by 5 pm on Thursday, 4th May 2023. The physical incapacity must have occurred after 5 pm on Tuesday, 25th April 2023. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 pm on Tuesday, 25th April 2023
