SECTION 21 OF THE TOWN POLICE CLAUSES ACT 1847 (TCPA 1847)

TEMPORARY TRAFFIC REGULATION ORDER (2024-3)

1. Ribble Valley Borough Council makes this Order in exercise of its powers under section 21 of the Town Police Clauses Act 1847 and any other enabling powers over an area of the highway being the length of Castle Street in the Town Centre of Clitheroe extending from a point adjacent to its junction with Castlegate to its junction with King Street/King Lane shown red on the attached plan.
2. The Order is made to avoid obstruction of the highway specified in paragraph 1 during the following event, the Ribble Valley Scooter Rally.
3. The Order shall come into operation at 12.00pm on Saturday, 28 September 2024 and will remain in force until 01.30am on Sunday, 29 September 2024.
4. While the Order is in operation all traffic including bicycles and pedestrian movement along the road will be temporarily restricted (except for emergency access) between 12.00pm on Saturday, 28 September 2024 and 01.30am on Sunday, 29 September 2024
5. An alternative route will be available for use while the Order is in force being from the Moor Lane direction following the current one way system and can proceed up Moor Lane on to Castlegate, turn left along and down Parson Lane and then turn right along Station Road and then turn right on to King Street and proceed along King Street to the junction with Castle Street and King Street then turn left on to Market Street shown blue on the attached plan.

6.All restrictions will be signed (and staffed) and will remain in force only for as long as is necessary.

7.Nothing in the Order will apply to:

- Anything done with the permission of or at the direction of a Police Officer.
- Any vehicle being used for police, fire brigade or ambulance purposes or for the purposes of a statutory undertaker in an emergency, such as the loss of supplies of gas, electricity or water to premises in the area, which the Order applies.

8.Access to properties adjoining the highway specified in paragraph 1 will not be affected by the Order.

9.All constables are hereby directed to enforce the provision of this Order.

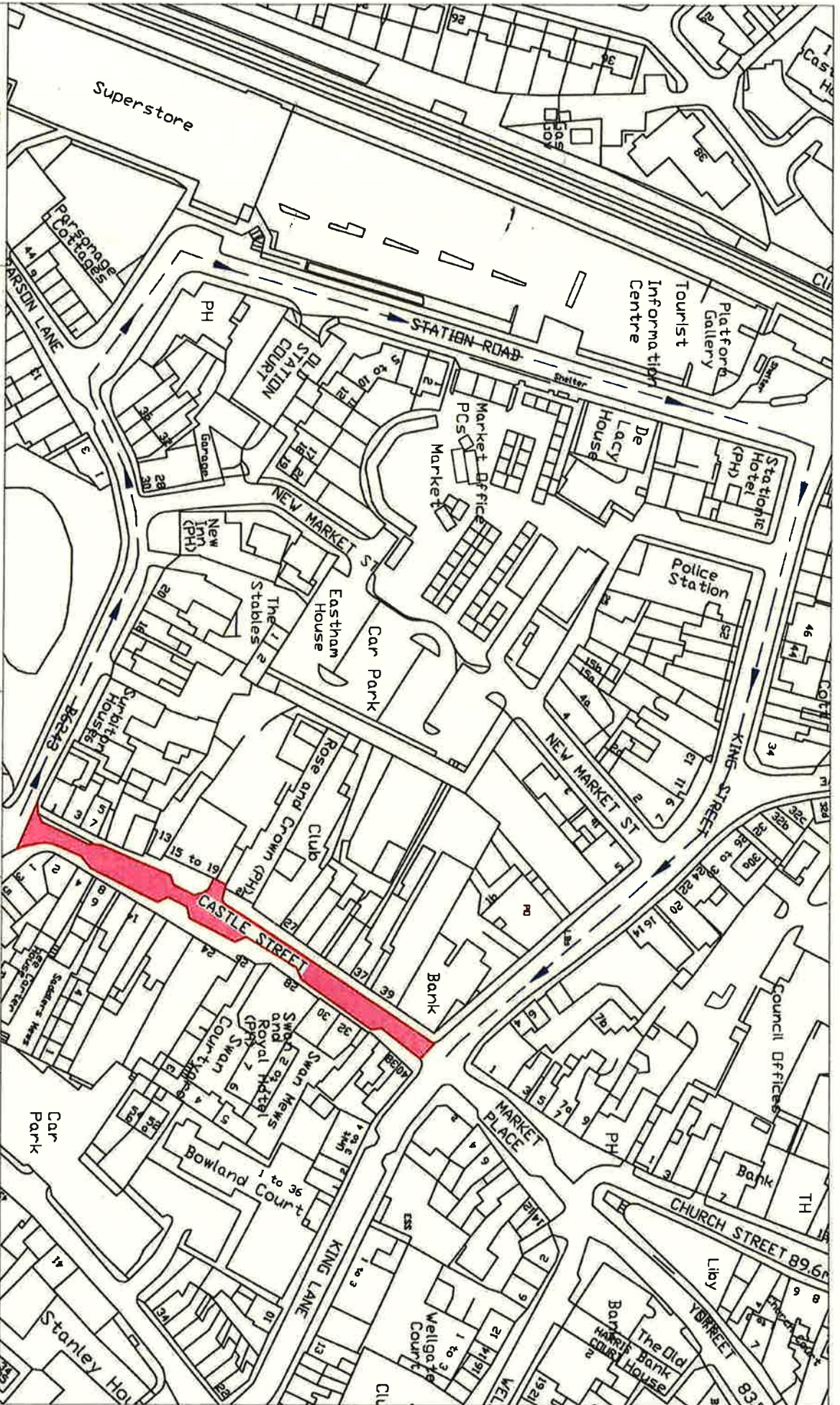
