SECTION 21 OF THE TOWN POLICE CLAUSES ACT 1847 (TCPA 1847)

TEMPORARY TRAFFIC REGULATION ORDER (2024-13)

1. Ribble Valley Borough Council makes this Order in exercise of its powers under section 21 of the Town Police Clauses Act 1847 and any other enabling powers over an area of the highways being –

- The length of Church Lane in the village of Whalley extending from its junction with King Street to outside the entrance to St Marys an All Saints Church ____
- The length of King Street in the village of Whalley extending from its junction with Church Lane to the War Memorial at the junction with Station Road _____

2. The Order is made to avoid obstruction of the highways specified in paragraph 1 during the following event, Whalley Remembrance Day Parade

3. The Order shall come into operation at 09.30am on Sunday 10 November 2024 and will remain in force until 12.30pm on Sunday 10 November 2024.

4. While the Order is in operation all traffic including bicycles and pedestrian movement along the road will be temporarily restricted (except for emergency access) between 09.30am and 12.30pm

5. There will be no alternative route available for the duration of the Order.

6. All restrictions will be signed (and staffed) and will remain in force only for as long as is necessary.

7.Nothing in the Order will apply to:

- Anything done with the permission of or at the direction of a Police Officer.
- Any vehicle being used for police, fire brigade or ambulance purposes or for the purposes of a statutory undertaker in an emergency, such as the loss of supplies of gas, electricity or water to premises in the area, which the Order applies.

8.Access to properties adjoining the highway specified in paragraph 1 will not be affected by the Order.

9.All constables are hereby directed to enforce the provision of this Order.

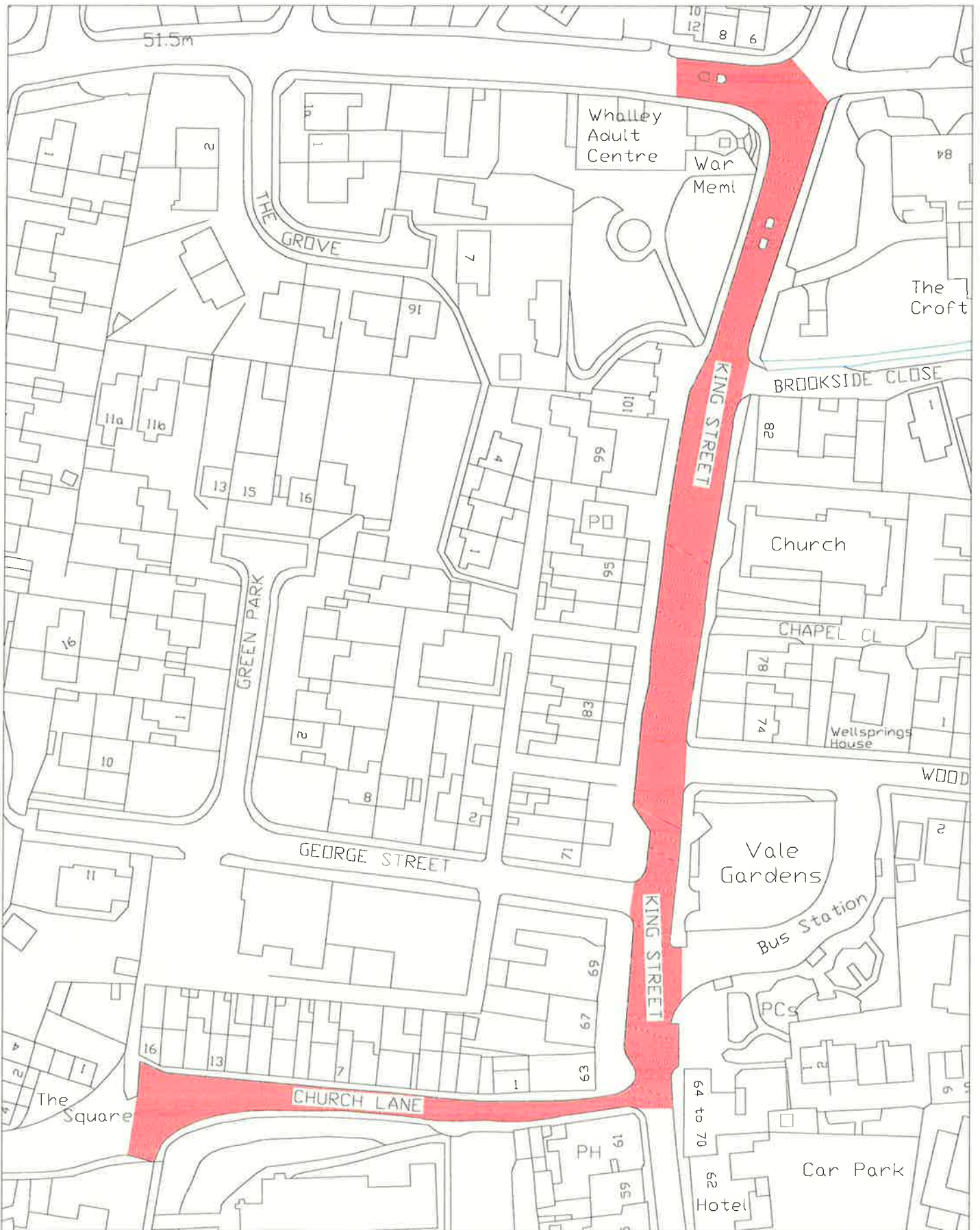
